

PUBLIC FINANCE MANAGEMENT ACT DETERMINATION OF STATUTORY FEES AND CHARGES FOR OFFICE OF CENSORSHIP

I, the Honourable RAINBO PAITA M.P., the Minister for Finance and Rural Development, having consulted the Minister for Religion, Youth & Community Development, make the following determination pursuant to Section 71A of the *Public Finances (Management) Act, 1995* (as amended) in respect of the statutory fees and charges imposed by the laws, including any regulations, subsidiary legislations or administrative directions, referred to herein—

- (a) revoke all prior determinations relating to statutory fees and charges imposed by the laws, including any regulations, subsidiary legislations or administrative directions, referred to herein;
- (b) determine the activities and services for which fees and charges shall apply to be those that are specific in the Schedule; and
- (c) determine the amount of those fees and charges to be those that are specified in the Schedule.

This determination shall take effect from the date of the publication of this notice in the *National Gazette*.

SUBJECT: REGISTRATION FEES FOR PUBLICATION PREMISES


This Circular Instruction is to inform you that the Ministry of Finance and Rural Development, under the Finance Management Act, repeal and replace Schedule 2 & 3 of the Classification of Publication (Censorship) Regulation.

As stipulated under Part III of the Classification of Publication (Censorship) Act 1989, Section 24-32, it is a requirement that operation of any prescribed activities, the operator must register the publication premises.

You are informed that implementation of the new fees was effective on the 4th of June 2020, the revised fees will be applicable to both new and renewal of registration of publication premises.

On the 28th of May, under the Public Finance Management Act, the Ministry of Finance and Rural Development approved new Censorship Fees and Charges and was gazetted as The National Gazette No. G330, 2020.

The gazette was released on the 4th of June 2020 and is to take effect on the same date.

You are hereby advised to take note of the changes in the new fees and charges on activities that falls under the Classification of Publication (Censorship) Act 1989.
